## Household Discount

Members who live at the same residential address may be eligible for a 10% household discount. Each Medicare-eligible adult must have a MediQ65 Medicare Supplement, be a permanent Arkansas resident, and live in the same household. The discounted rate will apply as long as all conditions are met.

Household is defined as condominium unit, a single-family home, or an apartment unit within an apartment complex. Assisted living facilities, group homes, adult day care facilities, nursing homes, or any other health residential facilities are not included in the definition of household.

<sup>1</sup>Plans F and G also have a high deductible option which require first paying a plan deductible of \$2,700 before the plan begins to pay. Once the plan deductible is met, the plan pays 100% of covered services for the rest of the calendar year. High deductible plan G does not cover the Medicare Part B deductible. However, high deductible plans F and G count your payment of the Medicare Part B deductible toward meeting the plan deductible.
