Exclude members who:

- ▶ Did not have a diagnosis of diabetes in any setting, during the measurement year or the year prior to the measurement year, and who had a diagnosis of polycystic ovarian syndrome, gestational diabetes, or steroid-induced diabetes, in any setting during the measurement year or the year prior to the measurement year.
- ▶ Were in hospice or used hospice services any time during the measurement year.
- ▶ Died any time during the measurement year.
- ▶ Received palliative care any time during the measurement year.

Hemoglobin A1c Control for Patients With Diabetes (HBD)

Controlled — <8.0%: Submit CPT[®] II code lab values

Poor Control — >9.0%: Submit CPT II code lab values

Members ages 18–75 with diabetes (type 1 and type 2) who were compliant with HbA1C control (<8.0) or non-compliant (>9.0)

Statin Therapy for Patients With Diabetes (SPD)

Received Statin Therapy

Dispensed at least one statin medication of any intensity

Statin Adherence 80%

Remained on statin medication of any intensity for at least 80% of the treatment period

Members ages 40–75 with diabetes who do not have clinical atherosclerotic cardiovascular disease (ASCVD)

Blood Pressure Control for Patients With Diabetes (BPD)

Controlled — <140/90: Submit CPT II code values

3078F = <80 mm Hg

3079F = 80–89 mm Hg

3080F = >90 mm Hg

Systolic:

3074F = <130 mm Hg

3075F = 130–139 mm Hg

3077F = >140 mm Hg
