

Clinical Policy: Belzutifan (Welireg)

Description

Belzutifan (Welireg[®]) is a hypoxia-inducible factor inhibitor.

FDA Approved Indication(s)

Welireg is indicated:

von Hippel-Lindau (VHL) disease

- For treatment of adult patients with VHL disease who require therapy for associated renal cell carcinoma (RCC), central nervous system (CNS) hemangioblastomas, or pancreatic neuroendocrine tumors (pNET), not requiring immediate surgery

Renal cell carcinoma with a clear cell component (ccRCC)

- In combination with pembrolizumab or pembrolizumab and berahyaluronidase alfa-pmph, for the adjuvant treatment of adult patients with ccRCC at intermediate-high or high risk of recurrence following nephrectomy, or following nephrectomy and resection of metastatic lesions
- As monotherapy, for treatment of adult patients with advanced ccRCC following a programmed death receptor-1 (PD-1) or programmed death-ligand 1 (PD-L1) inhibitor and a vascular endothelial growth factor tyrosine kinase inhibitor (VEGF-TKI)

Pheochromocytoma or paraganglioma (PPGL)

- Adult and pediatric patients 12 years and older with locally advanced, unresectable, or metastatic pheochromocytoma or PPGL

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results, or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation[®] that Welireg is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria**A. Von Hippel-Lindau Disease (must meet all):**

1. Diagnosis of VHL disease requiring therapy for associated RCC, CNS hemangioblastomas, or pNET, but not requiring immediate surgery;
2. Prescribed by or in consultation with an oncologist;
3. Age $\geq$ 18 years;
4. For Welireg requests, member must use belzutifan, if available, unless contraindicated or clinically significant adverse effects are experienced;

5. One of the following (a or b):
 - a. Welireg is prescribed as single-agent therapy;
 - b. For VHL-associated pNET: Welireg is prescribed concurrently with Sandostatin[®] LAR Depot (octreotide) or Somatuline[®] Depot (lanreotide);
6. Request meets one of the following (a or b):*
 - a. Dose meets both of the following (i and ii):
 - i. Dose does not exceed 120 mg (3 tablets) once daily;
 - ii. Dose is at least 40 mg (1 tablet) once daily;
 - b. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

**Prescribed regimen must be FDA-approved or recommended by NCCN*

Approval duration: 12 months

B. Renal Cell Carcinoma (must meet all):

1. Diagnosis of ccRCC;
2. Prescribed by or in consultation with an oncologist;
3. Age $\geq$ 18 years;
4. Prescribed in one of the following ways (a or b):
 - a. As a single-agent, and both of the following (i and ii)
 - i. Disease is advanced (unresectable, locally advanced, relapsed, or metastatic);
 - ii. Member has previously received both of the following (1 and 2):
 - 1) PD-1 or PD-L1 inhibitor (*see Appendix B for examples*), unless provider submits documentation that member previously received a first-line regimen containing only a VEGF-TKI;
 - 2) VEGF-TKI (*see Appendix B for examples*);
 - b. In combination with pembrolizumab or pembrolizumab and bevacizumab for adjuvant treatment, and one of the following (i or ii):
 - i. Member is intermediate-high or high risk of recurrence following nephrectomy;
 - ii. Following nephrectomy and resection of metastatic lesions;
5. For Welireg requests, member must use belzutifan, if available, unless contraindicated or clinically significant adverse effects are experienced;
6. For adjuvant treatment of ccRCC, duration of therapy does not exceed 54 weeks;
7. Request meets one of the following (a or b):*
 - a. Dose meets both of the following (i and ii):
 - i. Dose does not exceed 120 mg (3 tablets) once daily;
 - ii. Dose is at least 40 mg (1 tablet) once daily;
 - b. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

**Prescribed regimen must be FDA-approved or recommended by NCCN*

Approval duration: 12 months

C. Pheochromocytoma or Paraganglioma (must meet all):

1. Diagnosis of PPGL;
2. Prescribed by or in consultation with an oncologist;
3. Age $\geq$ 12 years;
4. Disease is locally advanced, unresectable, or metastatic;

5. For Welireg requests, member must use belzutifan, if available, unless contraindicated or clinically significant adverse effects are experienced;
 6. Welireg is prescribed as single-agent therapy;
 7. Request meets one of the following (a or b):*
 - a. Dose meets both of the following (i and ii):
 - i. One of the following (1 or 2):
 - 1) Adults or pediatrics weighing ≥ 40 kg: Dose does not exceed 120 mg (3 tablets) once daily;
 - 2) Pediatrics weighing < 40 kg: Dose does not exceed 80 mg (2 tablets) once daily;
 - ii. Dose is at least 40 mg (1 tablet) once daily;
 - b. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).
- *Prescribed regimen must be FDA-approved or recommended by NCCN*

Approval duration: 12 months

D. Other diagnoses/indications (must meet 1 or 2):

1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
 - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

II. Continued Therapy

A. All Indications in Section I (must meet all):

1. Currently receiving medication via Centene benefit, or documentation supports that member is currently receiving Welireg for a covered indication and has received this medication for at least 30 days;
2. Member is responding positively to therapy;
3. For adjuvant treatment of ccRCC, duration of therapy does not exceed 54 weeks;
4. For Welireg requests, member must use belzutifan, if available, unless contraindicated or clinically significant adverse effects are experienced;
5. If request is for a dose increase, request meets one of the following (a or b):*
 - a. New dose meets both of the following (i and ii):
 - i. One of the following (1 or 2) (*note: pediatric dosing applies only for PPGL*):

- 1) Adults or pediatrics weighing ≥ 40 kg: Dose does not exceed 120 mg (3 tablets) once daily;
- 2) Pediatrics weighing < 40 kg: Dose does not exceed 80 mg (2 tablets) once daily;
 - ii. Dose is at least 40 mg (1 tablet) once daily;
- b. New dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

**Prescribed regimen must be FDA-approved or recommended by NCCN*

Approval duration: 12 months

B. Other diagnoses/indications (must meet 1 or 2):

1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
 - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

III. Diagnoses/Indications for which coverage is NOT authorized:

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid or evidence of coverage documents.

Examples of VEGF-TKIs: Inlyta [®] (axitinib), Cabometyx [®] (cabozantinib), Lenvima [®] (lenvatinib), Votrient [®] (pazopanib), sorafenib (Nexavar [®]), sunitinib (Sutent [®]), Fotivda [®] (tivozanib)	Varies	Varies

PPGL	Adults and pediatric patients weighing ≥ 40 kg: 120 mg PO QD Pediatric patients weighing < 40 kg: 80 mg PO QD Until disease progression or unacceptable toxicity	120 mg/day
